Academy Grants - Twenty at-risk boys were provided boarding, clothing, education, soccer training, match participation, discipleship, and given life and vocational skills to be successful upon graduation from the academy. Programs include community service out-reach performed by athletes to improve their community.

Graduate Program - Empowered twelve athletes to transition out of our academy and into being self-sustaining.
